**MOTOR VEHICLE PHYSICAL INSPECTION FOR OHIO RESIDENTS  
AND MILITARY PERSONNEL TEMPORARILY LIVING OUT OF STATE**  
REQUIRED BY OHIO REVISED CODE (R.C.) 4505.061

*This form is for a motor vehicle that was previously titled / registered in another state and the owner (Ohio resident) is stationed or located out of state temporarily. This form must accompany the application for certificate of title and be filed with the clerk of courts. Void after 30 days.*

**REQUIRED FOR OHIO RESIDENTS LIVING OUT OF STATE TEMPORARILY:**

- Application must be in the name of an individual; no business names permitted.
- This inspection must be performed by the law enforcement agency where you are staying temporarily.
  - **Military Personnel:** The inspection must be performed by your commanding military authority.
- You must be an Ohio resident with an Ohio driver license (DL) or Ohio identification (ID) card number.
  - **Military Personnel:** If you do not have an Ohio DL or ID card, your social security number (SSN) may be listed on the form instead.
